## Pedersen & Houpt Wins High-Stakes Intellectual Property Case, Safeguarding iCONN Systems, LLC

Chicago, IL (March 28, 2013) Pedersen & Houpt, a Chicago-based law firm, successfully defended iCONN Systems, LLC, headquartered in Lombard, Illinois (Case No. 08-CH-15396). The company specializes in engineered interconnect product solutions. Plaintiff Conxall Corp. of Villa Park, IL claimed misappropriation of trade secrets against iCONN and six of its employees, and sought an eight-figure compensatory and punitive damage award. In addition, four of these individual defendants were sued for breach of contract related to confidentiality. The products in question, cable assemblies and panel mount connectors, are vital components of sophisticated, self-contained breathing apparatuses critical to the safety of fire fighters and miners.

After a five-week trial involving the testimony of 24 witnesses, including six experts, and thousands of designated exhibits, a 12-person jury returned a verdict in favor of defendant iCONN and its six employees. Rich Regole, President and CEO of iCONN, stated, "Our entire enterprise was at risk over this five-year pending litigation. The meticulous investigation completed by Pedersen & Houpt made it clear to the jury that plaintiff's allegations were false. Choosing the right legal advisor safeguarded our company, its shareholders and our valuable employees."
